## **Meaning of Home Rule**



### "MAKE THE RULES AT HOME"

Home Rule transfers the basic authority to act in municipal affairs from state law, as set forth by the General Assembly, to a local charter, locally drafted and adopted by municipal voters.

# Major Principles of Home Rule



Opportunity to shift responsibility from state legislature to local citizens

Allows for self-determination

Allows for flexibility in defining the structure, powers, and functions of the municipality

Opportunity to create a government that best meets the particular needs of the municipality


