Crash Synopsis:

This crash occurred as Unit 01 was traveling northbound on SR 153, South of N. Railroad Street, Woodward Twp., Clearfield County, PA. While traveling northbound, Unit 01 traveled off the eastbound shoulder striking a utility pole. Unit 01 struck the utility pole with the driver's side of the vehicle (fender/door) causing disabling damage. Unit 01 came to final rest facing south slightly off the roadway. Operator 01 failed to contact 911 or PSP following the crash. Operator 01 fled the scene following the crash.
