On 06/01/2024 at approximately 1609 hours, Unit 1 was traveling East on State Route 53, Beccaria Township, Clearfield County, PA. As Unit 1 was traveling East on State Route 53, Unit 2 was traveling East Bound in front of Unit 1. Unit 2 was slowing down to make a left-hand turn. Unit 1 moved into the left passing lane to overtake Unit 2. As Unit 2 started to make the left turn Unit 1 struck Unit 2 in the driver side. Unit 2 rolled onto its passenger side. Both Unit 1 and Unit 2 remained at their final rest position.

Operator 1 reported minor injuries and was transported by Madera EMS to UPMC Altoona Hospital.

Operator 2 reported minor injuries and was transported by Madera EMS to UPMC Altoona Hospital.

Both Units were towed by discount towing.
