An Officer from the CRPD stopped a vehicle along SR 879 in Lawrence Township after it had committed several traffic violations. The vehicle which was registered from Texas pulled into the parking lot of Sheetz in Lawrence Township.

The Officer detected an odor of marijuana coming from the vehicle that was occupied by two males, one from Detroit Michigan and the other from Cincinnati Ohio. He requested assistance and as another Officer pulled on scene the passenger fled on foot running behind Sheetz and into the wooded area.

The driver was taken into custody and a search warrant was executed on the vehicle.

The passenger was located hiding in a vehicle that was inside a car lot. He was taken into custody as well. He was located with the assistance of a drone from the Lawrence Township Fire Department.

Both males were taken to the jail on various charges.
