7. INCIDENT DETAILS

CRPD Officers located JAMIE LANSBERRY in a parking lot along the 300 block of E. Locust St. Officers were aware that LANSBERRY had an active arrest warrant through PA State Parole. Lansberry attempted to hide her identity by providing police a false name. Lansberry was also found to be in possession of 2 PA driver licenses, which were not hers. She was also found to be in possession of several bank cars that were not hers.

LANSBERRY was transported to the Clearfield Jail on the warrant and additional charges.
