POLICE ARRIVED AND LEARNED THAT A VEHICLE DRIVEN BY A CLEARFIELD WOMAN TURNED FROM N. 2ND ST ONTO BRIDGE ST INTO THE PATH OF A MOTORCYCLE BEING OPERATED BY A DUBOIS MAN.

THE MALE SUFFERED MODERATE INJURIES AND WAS TRANSPORTED TO PENN HIGHLANDS DUBOIS FOR TREATMENT. THE FEMALE WAS NOT INJURED IN THE CRASH.
