This two UNIT vehicle crash occurred on SR 970/Shawville Hwy near the intersection of Hoopup Rd in Bradford Twp, Clearfield County, PA. UNIT 2 was traveling South on SR 970/Shawville Hwy and the OPERATOR of UNIT 1 was pulling out of Hoopup Rd and the OPERATOR did not see UNIT 2 coming and struck it at it's 9 o'clock position. After impact, UNIT 1 spun in a counterclockwise manner coming to final rest facing East on Hoopup Rd. Both vehicles were able to pull off of the roadway where they came to final rest. The OPERATOR of UNIT 1 was charged with a Vehicle Code violation through District Court 46-3-03. Assisted at the scene by Bigler Boyz.

Crash Synopsis:

This two-vehicle crash occurred as Unit #1 and Unit #2 were both traveling east on Interstate 80, Pine Twp., Clearfield County PA. Unit #1 was traveling in the right-hand lane behind Unit #2, when Unit #2 stopped in the roadway due to a buildup of backlog traffic ahead of Unit #2. Operator #1 did not observe Unit #2 had stopped and struck Unit # 2 in the rear trailer of Unit #2. After impact both units were able to move off the roadway. This was final rest upon my arrival.

Unit #2 sustained minor cosmetic damage on the rear of a trailing unit. Unit #1 sustained minor cosmetic damage to its lower front bumper.

SYNOPSIS:

This crash occurred as Unit 1 failed to yield to oncoming traffic after stopping at a posted stop sign at the intersection of Reed St and Teutonic Ave (SR 53). Unit 1 struck Unit 2 in the front right bumper area and also made contact with the entire passenger side of the vehicle. Unit 1 came to final rest in the center of the roadway while Unit 2 was propelled off the roadway into a yard. Both units obtained heavy damage as a result of the crash and were disabled.
