Crash Synopsis:

Unit 02 was traveling on S.R. 879, when the operator of Unit 01 exited from I-80 West bound, failing to stop at the posted stop sign. The front of Unit 01 struck the rear driver side of Unit 02, causing Unit 02 to spin and roll onto its side. Minor injuries were reported but EMS transport was refused. Both vehicles were towed from the scene.
