NO THREATS WERE LOCATED AND STAFF WAS ABLE TO RETURN TO WORK.

7. INCIDENT DETAILS

CRPD OFFICERS ARRESTED A 42-YEAR-OLD FLORIDA MALE FOR DRIVING UNDER THE INFLUENCE AFTER OFFICERS OBSERVED HIM STANDING ON THE EXTERIOR OF HIS VEHICLE ALONG N. 3RD ST.

OFFICERS REPORT THAT WHILE ON PATROL THEY NOTICED A VEHICLE SITTING IN THE MIDDLE OF THE ROADWAY OF REED ST AND N. 3RD ST. THE DRIVERS DOOR WAS OPEN AND THERE WAS EXCESSIVE MUSIC PLAYING FROM THE VEHICLE. AS OFFICERS APPROACHED, THEY LOCATED THE OWNER STANDING ON THE FRONT HOOD OF THE VEHICLE JUMPING UP AND DOWN. THE MALE THEN WENT FROM THE HOOD TO THE TOP OF HIS VEHICLE BEFORE HE NOTICED POLICE.

THE MALE WAS FOUND TO BE INOTXICATED WITH A BLOOD CONTENT AMOST 3 TIMES THE LEGAL LIMIT. HE WAS PLACED IN THE JAIL AWAITING ARRAIGNMENT.
