On October 28<sup>th</sup> 2024 Officers received a report of a sexual assault, which occurred at a residence within Clearfield Borough. A warrant was obtained for DERBEQUE and he was housed in the Clearfield County Jail, pending arraignment. DERBEQUE has been charged with Sexual Assault, Aggravated Indecent Assault, Corruption of Minors and Indecent Assault.
