Crash Synopsis:

Unit 02 was stopped in the turning lane of the Clearfield Mall located on S.R. 322. While Unit 02 was waiting to negotiate a left hand turn into the mall, a silver in color SUV, unknown registration, side swiped the front passenger side of Unit 02 with the front driver side of Unit 01, causing minor damage. The operator of Unit 01 continued to travel east bound on S.R. 322 and did not stop or return to the scene. There were no injuries reported and Unit 02 was able to be driven from the scene.

7. INCIDENT DETAILS

CRPD CONDUCTED A VEHICLE STOP ALONG KELLY AVE IN CLEARFIELD AVE KNOWING THAT THE DRIVER HAD A SUSPENDED LICENSE. THE FEMALE PASSENGER WAS IDENTIFIED AS DANIELLE GISEWHITE. GISEWHITE WAS FOUND TO HAVE AN ACTIVE ARREST WARRANT FROM BLAIR COUNTY. SHE WAS TAKEN INTO CUSTODY AND FOUND TO HAVE DRUG PARAPAHERNALIA.

SHE WAS LODGED IN THE COUNTY JAIL ON THE WARRANT AND WILL FACE DRUG PARAPHERNALIA CHARGES.

THE DRIVER WAS CITED AND THE VEHICLE WAS TOWED.
