**This station investigated a crash that occurred on Interstate 80 at MM 113.2, eastbound in Pine Township, Clearfield County. At the time of this crash, there was a sudden rain storm traveling through the area that dropped a large amount of water in a short amount time. This rain storm caused significant standing water on the roadway. Unit #1 was traveling eastbound when Operator #1 began to lose control due to the standing water on the roadway. Unit #1 traveled off the roadway and into the median. Unit #1 then struck a ditch, hit an embankment, and then overturned onto its roof. Unit #1 suffered disabling damaging. The occupants of Unit #1 were transported by Clearfield EMS to Penn Highlands Dubois for suspected minor injuries.**

**Unit #1 was towed from the scene by Bigler Boyz Towing.**

**A crash report notice was mailed to the owner/operator of Unit #1.**
